"I hereby state that the above information is, to the best of my knowledge, true and accurate. If hired by Lovell's All-Star Pets dba Peace Valley Pet Care you will be paid as an Independent Contractor and be responsible for paying your own local, state and federal taxes, and that we will issue you a 1099 at the end on each year that you are employed as an Independent Contractor with our company. As an Independent Contractor you are responsible to provide your own Pennsylvania registered, reliable transportation, in which you are responsible for all of its maintenance, fuel, auto insurance. We do not pay mileage or provide a health coverage plan. We do carry general liability Insurance plan and are bonded. You also agree that if you resign, or are terminated for any reason that you will return any property of Lovell's All-Star Pets dba Peace Valley Pet Care that includes all clients keys, unused self addressed stamped envelopes, any clients checks or cash for payment of services that you picked up at our clients home with in 24 hours of said resignation or termination. If hired by Lovell's All-Star Pets dba Peace Valley Pet Care that I agree to sign a non-compete contract that states that I will not directly compete or preform any pet care in direct competition with Lovell's All-Star Pets dba Peace Valley Pet Care while contracted to Lovell's All-Star Pets dba Peace Valley Pet Care and also agree to not directly compete against Lovell's All-Star Pets dba Peace Valley Pet Care for a period of two years after leaving or if terminated as outlined below.

**NON COMPETE INDEPENDENT CONTRACTOR AGREEMENT**

For good consideration and as inducement for Lovell's All-Star Pets dba Peace Valley Pet Care to employ you "ONLY" if hired as a (Independent Contractor), residing at their current address listed in the Lovell's All-Star Pets dba Peace Valley Pet Care Application, the Independent Contractor hereby agrees not to directly solicit existing clients or the Company and its successors and assigns during the period of employment and for a period of 2 years following termination of employment and notwithstanding the cause or reason for termination. The Independent Contractor also agrees not to compete with the company during his or her term of employment and to safeguard any confidential information concerning the activities of the Company or the identity and activities of its customers indefinitely.

The term "not compete" as used herein shall mean that the independent contractor shall not consult or be employed in a business substantially similar to, or competitive with, the present business of the Company or such other business activity in which the Company may substantially engage during the term of employment or to solicit directly or indirectly or except business from any customers of Lovell's All-Star Pets dba Peace Valley Pet Care.

The Independent Contractor acknowledges that the company shall or may in reliance of this agreement provide access to trade secrets, customers and other confidential data and good will. The Independent Contractor agrees to retain said information as confidential and not to use said information on his or her own behalf or disclose same to any third party. The covenant shall be of indefinite duration.

The non-compete agreement shall extend only for a radius of 20 miles from the present location of the companies PO Box 1517, Doylestown, PA. 18901 and shall be in force and effect for two (2) years, commencing with the date of employment termination.

This Non-Compete and confidentially agreement shall be enforceable by an injunction or by other equitable relief and the Independent Contractor agrees and waives any requirement for the Company to post bond or other security in order to obtain an injunction or other equitable relief from a Court of competent jurisdiction. The Independent Contractor also agrees that in the event of legal action either at law or in equity or both needs to be brought by the company to enforce and vindicate the rights and interests of the Company, the Independent Contractor shall pay all legal costs of enforcement, including but not limited to reasonable consul fees and any expert witness fees including those required to establish the damages sustained by the Company in the event of breach or breaches of this agreement by the Independent Contractor.

This agreement shall be binding only if hired upon and inure to the benefit of the parties, their successors, assigns and personal representatives."
